

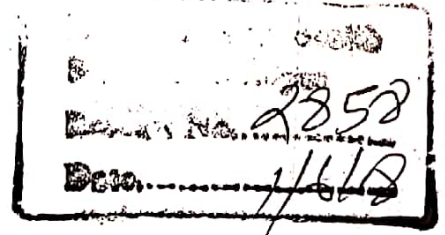

I would like to highlight the initiative taken by Ministry of Health & Family Welfare, (Nursing Section) & Indian Nursing Council, that the National Health Policy, 2017 launched by Govt. of India vide File No. Z.28015/73/2016 - N dated 5<sup>th</sup> Oct.' 2017 has identified 06 (six) key initiative to be taken up by Indian Nursing Council and will be monitored by Prime Minister Office under National Health Policy (NHP), 2017 concerning to nursing along with activities, namely:

1. Single Entry level for nursing
2. Licentiate exams
3. Live Registration
4. Continuing Nursing Education
5. Nurse Practitioner course
6. Nurse Practitioner in PHC.

Also please find here with letter sent by Joint Secretary, Department of Health & Family Welfare, Govt. of India addressed to all Secretaries, Department of Health & Family Welfare of all States (copy enclosed) on the above mentioned subject. The Indian Nursing Council has placed the order to an empanelled agency M/s. FINO Pay Tech Pvt. Ltd for enrolment of nurses (copy enclosed). In this regard, necessary work order has been issued by INC to undertake the enrolment of nurses in the State of Manipur (copy enclosed).

I, therefore, request you to kindly issue suitable directives to the Director RIMS, the Director JNIMS, all CMOs District Hospitals, Nursing Institutions in the State, Nursing Home/PHCs/ CHCs & all the health establishment both private & Govt. to extend full cooperation to enroll the nurses (Registered Nurse, Registered Midwife/ ANM/FHW/LHV) to the concerned in cluster mode which is given as **Annexure - I**.

Those failing to report may miss all opportunities of their careers as it is to be reported to Ministry of Health & Family Welfare, GoI, State Government and Indian Nursing Council to do proper manpower planning and to take policy decision based on accurate data.
